

# New Mexico Math Tutoring Corp Tutor Job Description

#### **Position Overview**

New Mexico Public Education Department New Mexico Math Tutoring Corp Tutors manage real-time, virtual math tutoring for a small group 3-4 algebra I high school students and promote academic success by focusing intently to provide individualized instruction and build strong relationships with students during their year of service. During a typical tutoring session, tutors will work with up to four (4) students at a time. Tutors will implement Saga's proprietary curriculum to foster academic success and help students reach their goals. In addition to offering academic support, tutors also serve as student advocates and mentors and must build strong, meaningful relationships with their students.

#### Responsibilities

- Provide three (3) 45 minute math tutoring sessions for 14 weeks (January 2023 April 2023) to a caseload of 3-4 algebra I students.
- Use student data to differentiate math instruction for your students and adapt lesson plans as needed.
- Maintain regular ongoing communication with student's parents/guardians and math teachers.
- Navigate varying technology, both hardware and software, and troubleshoot technical issues as they arise.
- Use Saga's proprietary curriculum and virtual platform to conduct all tutoring responsibilities.
- Proactively approach work in order to complete deliverables on time and maintain proper work-life balance.
- Check and respond to emails daily and regularly.
- Consult with your assigned Regional Lead Math Tutor.
- Complete asynchronous and synchronous High-Dosage Tutoring training.

- Prior experience coaching, tutoring, or mentoring students, preferred but not required.
- Submit background check per Southwest Regional Education Cooperative requirements.
